Heat stroke, exhaustion, dehydration and other heat related conditions are not covered in any way. Remember that a Pug can over heat quickly & easily and may die as a result of over heating. Keep Indoors.

A Puppy showing any serious genetic or congenital defect will be replaced as follows: Animal must show defect by one year of age and be examined by a veterinarian. We must be notified at once , in writing , by the Vet. Our Vet will interpret the report and if he concurs, then a replacement puppy will be given. Also, any puppy with a defect must be returned, in good condition other than specified problem at the cost of the buyer or euthanized with the prior permission from us to qualify for a replacement puppy.

No refund in part or full will be given for any reason.

This Guarantee applies to the original owner only and is not transferable to a second party. No replacement puppy will be given if the puppy had been bred, spayed, neutered, or altered in any way, or euthanized without our permission. Any condition that is minor, correctable, or a breed related minor condition is not covered and no condition which could go away, or is considered to be a condition which a puppy will likely grow out of is covered. There are certain disorders that may be caused by environmental factors . For example Allergies, Thyroid dysfunction, demodectic mange and other autoimmune disorders that are not covered by this guarantee.
